Support the one world foundation Free Education School.

The one world foundation Free Education School provides tuition for over 1,100 children, juveniles and adults in addition to the state-school education. The free education project includes Montessori pre-school classes, dressmaking classes for the mothers of pre-school children, English and Tamil language lessons, and professional training in computers and photography. The certificates from the Free Education School are state-recognised. The training offers young people better prospects for the future.

The school costs €180,000 a year to run, of which two thirds alone (€120,000) are for the salaries of the forty or so teachers. Some of the costs are covered by the proceeds from our Ayurveda resort in Ahungalla, but we are reliant on support for the maintenance and long-term future of our school.
